## Changes



## MODULAR MODELING IN THE NEW JERSEY DIVISION

I hope everyone is enjoying the (so far) mild the winter. As a skier, I prefer snow, but as the one who has to shovel the driveway, well....

On the modular railroading front, there have been a number of opportunities to kick off the year that demonstrated the benefits of this approach to model railroading. I was up at the annual train show in Springfield, MA and there were a number of modular railroads on display in many scales. If you noticed, there was also a Free-mo layout there in the Mallery building. The New England Free-mo group had a U shaped layout up and running with some neat scenes and nice structures. Also of interest was how they used multiple sections on some modules to expand them with more track and scenery while still keeping the end plates compliant with the spec.

The following weekend, I was down in Timonium, MD for the winter event of this regular train show. Capitol Free-mo was on hand and I set up with their layout, anchoring one end with my Woodstown Junction module. We were in a different section of the building than previous shows and I think that helped get more folks passing by and checking out the layout.

I did have the opportunity to do a short video using a new device called the iCar. This allowed me to use my phone to shoot video straight down the track like you are riding the front of a locomotive. Check it out on YouTube at www.youtube.com/watch?v=6MiGJj5wmMA

The car was pretty popular at the show and we also used it on the Four County Scale Model Engineers modular layout. You can check out their video at

It is a neat device and I look forward to using it on the home layout as well. If you are interested in a car for yourself, you can find out more about it at minutemanscalemodels.com

With the upcoming March Meet, we hope to have some new Free-mo modules to make their debut. This will give everyone a chance to see some in progress modules and how they were constructed.

One thing I have seen with the various Free-mo groups is that there are a number of different construction methods for the legs, frame and surface of a module, and all of them are correct. That is one of the great things about Free-mo.





No one is dictating how you build your legs, or how you attach them, or what material to use for the top of your module. All that matters in the bench work phase is that your ends meet the  $6" \times 24"$  standard. Other than that, use

> whatever materials and construction method you want. One of the Capital Free -mo guys actually uses PVC pipe in a tripod configuration to support his ends. Some modules have plywood tops, but most use foam. Some legs slip into pockets and some bolt or clamp on. Do what works, and move on to the fun part, the actual model railroading that takes place on top of the module!

Find your way to I 295 North. Take exit 60 onto I 195 East. Proceed about a mile and exit onto Broad Street. Take the third right onto Kim Valley Rd. just after the Rite Aid and then left onto Fisher place. You'll see the building behind the ball field.

### From eastern South Jersey


Follow the directions above, or take **US 30 to US 206 in Hammonton.** Proceed **north** on **US 206** to **Bordentown** and merge **right** onto **US 130 North**. Follow **US 130** to Broad Street. Take the Broad Street exit, turn right onto broad Street, proceed about 0.3 miles and turn left onto Kirby Ave. Go straight across Fisher Place into the driveway for Switlik Park.

### From North Jersey shore points


Take I 195 West to Exit 2. This exit only goes north, so at the bottom of the ramp (Broad St. northbound), turn left at the light onto Hempstead and follow around to Broad Street southbound. Take the third right onto Kim Valley Rd. just after the Rite Aid and then left onto Fisher place. You'll see the building behind the ball field.




Above: Will the cop try to give the engineer a speeding ticket? To find out, visit Mike Prokop's railroad on the tour after the meet on March 10.


