May Meet Joint NJD GSD Effort

As has become custom, we are again holding a joint meet with the Garden State Division. This year it's their turn to host the festivities.

We will have two clinicians presenting. From our division, we'll have Chris Conaway showing us how he applies static grass to enhance his scenery. It will include the basics of what it is, how it works and how he applied it over his existing scenery to give his model railroad scenery more texture and a more realistic appearance. He will also do a demonstration using the materials on a small diorama that he has built for the purpose. There will be a hand out for the group that includes a Power Point presentation.

Our second clinic will be presented by the Garden State Division's Bill Frankenfield. In keeping with the scenery theme, Bill will show us how he makes lightweight and removable scenery. Bill will revisit the rapid scenery style that made Zip Texturing popular.

While traditional foam scenery is dependent upon layering solid blocks of foam and long drying periods, this system can be used to

make light weight scenery that is strong and fast to build. Large areas can be built and scenery added with little waste and can be made removable for tunnels and hidden access areas. One can build upon the scenery and add detail and finishing touches without having to strip down the existing scene.

The GSD does not have a contest at their meets, but they do have a session they call "Bring and Brag." Bring your favorite model, be it motive power, rolling stock, a structure, or whatever you would like to show off to the group.

We'll also have all the trappings of a New Jersey Division meet, so we'll see old friends, perhaps make a few new friends, and generally enjoy the day!

The afternoon tour includes two railroads, both in the New Jersey Division, that we don't often get to see since they are in the northern part of the division, Please take the opportunity to stop by to see the railroads of Dick Genther and Joe Garsick. As usual, maps and directions will be available at the meet.

I've noted in my announcements that the Pennsy was number one. Lots of you agreed and some didn't and some grunted and boo'd a little. That's ok, here's my reasons I say the PRR is #1. Even if your not a Pennsy fan, it's hard to disagree after considering the following.


Recently, while researching information about the Camden New Jersey waterfront for my Free-mo module on Reading's Linden Street freight station, I found on a website a copy of the 1906 Camden phone book. Just for a goof I figured I'd look up to see if the Reading railroad had a telephone at the Linden street station and if so, what was the number. Why not? Not that it was that helpful or significant with the building of my module but what the heck, I had a few minutes and I was curious. Well, I made a few very interesting discoveries. First of all, in 1906, don't look for the Reading railroad's name or identity in any part of southern New Jersey. After not finding Reading in the alphabetical listing and figuring that was the end of my search, it hit me that the Reading railroad was not called or known as the Reading but

actually back then it was the Atlantic City RR. Ok, so I found the Atlantic City railroad in the phone book but they didn't have a phone listing for the freight station at Linden street. As you can see in the listing, there was phone service at the Ferry facilities at Kaighn's point, and also at 521 Cooper St. The Cooper location was near

to Linden street but too many blocks away to effectively provide service there.

The next idea I had was to look up the Pennsylvania railroad in the 1906 phone book. I knew now to look for the PRR

under the listing that the railroad went by back then in Camden and southern NJ, as the West Jersey and Seashore. Well, sure enough, and it figures, the WJ&S (the Pennsy), had many telephones in service in 1906. Take a good look at the listing for details on which WJ&S locations had service. I also found in this 1906 phone book that the WJ&S was also listed under the Pennsylvania RR with what looks like identical listings.

Now here comes the interesting part. Notice the clout and standing and importance the Pennsy had at the time in the city of Camden. The main phone

number for the WJ&S (PRR) was Camden 1. That's amazing, who gets a phone number like that, " #1". Not the mayor of Camden or city hall or for that matter, the president of the United States; no, the Pennsylvania railroad! Oh well, after all these years the rail fans and modelers of the Pennsy that boasted that their railroad was the best, the standard of the world, the number ONE railroad on the planet, seems to simply just had it confused with the railroad's phone number! Just goes to show you how those Pennsy fans can easily get mislead! Us New York Central fans, however, would never be pretentious like those PRR guys, after all, our railroad was the "Road to the Future."





The Golden Spike Award will be awarded to any NMRA member who has completed the Qualifications Checkist, obtained the necessary signatures and who does not hold MMR status. It will be administered by the regional and divisional AP Chairs. AP regulations and definitions apply for scratch building and super detailing. To quality for the award the member must complete the following checklist, obtain the signature of the divisional AP Chair or another NMRA member designated by the divisional Chair. The divisional Chair will submit the signed form to the regional AP Chair who will issue the Golden Spike Award certificate.	ber who has completed the Qualifications Check-MR status. It will be administered by the regional for scratch building and super detailing. To qualicist, obtain the signature of the divisional AP Thair. QUALIFICATIONS CHECKLIST:	

1. Rolling Stock (Motive Power & Cars):

Display six units of rolling stock either scratch built, craftsman kits or super-detailed commercial kits.

2. Model Railroad Setting (Structures & Scenery)

Construct a minimum of eight square feet of layout including scenery.

Construct five structures either scratch built, craftsman kits or super detailed commercial kits. If a

module has less than five structures, additional structures separate from the scene may be presented.
